Farm Bill with Strong Crop Insurance, Safety Net, Export Funding Signed into Law: We are expecting a Farm Bill extension, and will continue to work for passage of the Farm Bill in 2024.

Ethanol's Future Is Secured with Passage of Next Generation Fuels Act:

This key bill, introduced in both the House and Senate, would create a standard for ethanol's use and preserve the internal combustion engine, instead of forcing a fully electric future. KCGA and NCGA are working on several fronts to make sure the administration doesn't focus solely on electric vehicles for decarbonizing the transportation sector.

Applications Now Open for KCGA/NCGA Scholarships

The Next Generation Scholarship program is part of an effort by Kansas corn farmers to support students in post-secondary education who will make an impact in the corn and agriculture industries. Kansas Corn Leaders Fill Roles on NCGA Teams

Kansas Corn leaders and staff have been appointed to NCGA Action Teams. Chad Epler, Columbus: Market Development Action Team and serves as team vice chair; Brett Grauerholz, Republic: Production Technology Access Action Team; Brent Rogers, Hoxie: Risk Management and Transportation Action Team; Tanner McNinch, Ness City: Stewardship Action Team; Sue Schulte, Kansas Corn staff: Member and Consumer Engagement Action Team. Rogers will serve on the NCGA Nominating Committee and Epler will serve on the Resolutions Committee. Matt Splitter, Lyons, represents NCGA on the Mapping and Analyzing Connectivity on Agricultural Lands working group for the FCC's Precision Agriculture Connectivity Task Force.

KCGA Active In Sustainable Aviation Fuel Discussion

Sixteen of the nation's top corn grower leaders, including KCGA President Brent Rogers, Hoxie, asked that aviation biofuels be treated fairly in tax policy by using the best standards available. The corn leaders sent a letter recently to U.S. Treasury Secretary Janet Yellen encouraging her to adopt the Department of Energy's (DOE) Argonne National Laboratory Greenhouse Gases, Regulated Emissions, and Energy use in Transportation (GREET) model as her agency works with the IRS to determine which biofuels can qualify for sustainable aviation fuel tax credits under the Inflation Reduction Act. A similar letter, signed by fuel producers and seven major airlines, as well as Boeing and GE Aerospace. If adopted, the move could open the door for further development of ethanol-based aviation fuel. Kansas Corn has been closely involved in efforts to advance the adoption of ethanol-based sustainable aviation fuel (SAF). The letter comes as ethanol is being considered for use in sustainable aviation fuel. Ethanol has been used for years to lower greenhouse gas emissions from cars and trucks while saving consumers money at the pump, and experts say the biofuel would do for airplanes what it has done for autos.

Cooperative Effort Leads to Progress on Rattlesnake/Quivira Issue

10-12-23—Encouraged by the work to manage water use in the Rattlesnake Creek Basin, the U.S. Fish and Wildlife Service announced it will withdraw the call for water for 2024 for the Quivira National Wildlife Refuge, to allow a working group to develop options to be implemented in 2025. This builds momentum for continued work with local partners such as GMD 5 and WaterPACK to seek voluntary water conservation efforts to remedy the impairment. This has become a cornerstone issue for KCGA. We are working to protect access to water on nearly half a million irrigated acres.

BOTTOM LINE: KCGA has provided resources and expertise to reach this positive development for the area's economy.

Corn Growers, Sen. Moran, Rep. Mann, Led Effort to Lower Phosphate Duties

11-2-23—Corn growers received good news in November as the U.S. Department of Commerce announced it was lowering duties placed on phosphate fertilizers imported from Morocco from 19.97% to 2.12%.

Leaders from KCGA and NCGA, who have been vocal opponents of the duties, applauded the decision, calling it a big win for corn growers.

A bicameral letter, led by Senator Moran and Rep. Mann, and a letter from growers led by NCGA and KCGA were instrumental in bringing this issue to the forefront.

BOTTOM LINE: This action could help with fertilizer costs which were driven up over the past two years by duties and tariffs.

Kansas Corn Encourages Growers to Apply for Irrigation Tech Funds

11-7-23—Kansas Corn leaders urge farmers to apply for new cost share assistance and incentive payments now available to assist growers with irrigation efficiency technology through the KDA Division of Conservation. KCGA and other ag groups worked to secure this funding in the 2023 legislative session. Apply at your conservation district office. This is a meaningful investment making about \$550,000 available to help growers adopt irrigation technology. It's great to see this funding come to fruition to help our growers implement irrigation technology that can have real impact for water conservation.

BOTTOM LINE: KCGA's work to get this funding through the state water plan will help irrigation efficiency in Kansas.
